## **CONDITIONS AND COMPETITION RULES**

### **The host of the tournament is responsible for**

- \* Providing accommodation&meals during the tournament (max.8 persons/team: 6boxers + 2officials) **for price of 25 euros per day per person**. The host will provide accommodation&meals for AIBA R&J.
- \* Accommodation in **twin rooms** (single rooms for extra charge only, unless uneven number of people in the delegation)
- \* Transportation from/to **Tampere** airport, railway station and bus station upon arrival/departure including local transportation needed during the tournament
- \* Training facilities
- \* Tournament awards
- \* European boxers must have the European Health Insurance Card with them in case of medical services needed.

**Travel costs to Tampere and back home are the responsibility of the participating team.**

**All teams must pay the accommodation fee at the time of arrival in cash (EURO only). Team Delegations will not be able to receive accreditation cards and hotel rooms before the payment has been fully made.**

### **Composition of the official delegation**

- \* Each participating association may bring only one team and one boxer in each weight category.
- \* At the official delegation teams may have max. 6 boxers, two **officials** (team leader & coach **OR** 2 coaches) and one **AIBA referee/judge**.
- \* If there are less than 3 boxers in a team, the team may **not include more officials than boxers**.
- \* **Each participating association MUST bring AIBA Star-qualified referee/judge.**
- \* Additional persons outside the official delegation are charged **100 Euro/day/person** (full board) for their accommodation. The same price applies to the teams that arrive prior to 15<sup>th</sup> October 2014 or leaving after 20<sup>th</sup> October 2014.

### **Competition Rules**

The tournament will be carried out in 10 official weight categories and according to the AIBA rules. The participants must have equipment that is in conformity with the AIBA rules: vest, trunks, gum shield, an **up-to-date record book**, etc. Bouts consist of 3 rounds, 3 minutes each. Delegations can participate in the tournament only by fulfilling the conditions set in this invitation.
