INTERNATIONAL TOURNAMENT “WORLD CUP OF PETROLEUM COUNTRIES” City of Khanty-Mansiysk, Russia, 16-21 December 2015

INVITATION

Boxing Federation of Russia has a pleasure to invite your National boxing team (men and women) to take part in the **International Tournament “World Cup of Petroleum Countries”** that will be held in the city of Khanty-Mansiysk, Russia on **16-21 December 2015**. Venue: Tennis Centre, Khanty-Mansiysk, Studencheskaya Street, 21.

Date of arrival to Moscow – 15 December 2015 (all participants should be at Moscow Vnukovo /VKO/ or Domodedovo /DME/ Airport by 17:00 Moscow time).

Date of departure from Moscow – 21 December 2015 (after 14.00 Moscow time).

TEAM COMPOSITION:

The Tournament will be held in accordance with valid AIBA Rules in the following weight categories:

Men (born in 1996 and older): 49, 52, 56, 60, 64, 69, 75, 81, 91, +91 kg.

Women (born in 1996 and older): 51, 54, 60, 75 kg.

Bouts will consist of:

Men – 3 rounds x 3 minutes with 1 minute break between the rounds.

Women – 4 rounds x 2 minutes with 1 minute break between the rounds.

Team composition:

- **6 athletes (male and female)**
- **2 coaches**

Each athlete should have valid AIBA Record Book. Also please bring your National Flag and Anthem on a cassette or CD.

FINANCIAL CONDITIONS:

Participants will be responsible for their travel expenses to/from Moscow. ***Your team should arrive to Moscow on 15 December 2015 to Vnukovo (VKO) or Domodedovo (DME) Airport by 17:00, as LOC will provide air fare from Moscow by regular flights.***

Accommodation with full board, local transportation (including air fare Moscow-Khanty-Mansiysk-Moscow) for Official Delegations (max 08 persons) will be covered by the Organizers.

Extra persons and those teams who arrive before 16 December and depart after 21 December should pay for their accommodation and meals **50 EURO per person per day including meals**. All extra charges should be paid to the Organizers in cash upon arrival.

We kindly ask you to inform the Organizers about extra persons in advance.

AWARDS:

The winners in each weight category will be awarded with Medals, Diplomas, Cups and money prizes. Coaches of all winners also will be awarded with money prizes.

VISA:

Those who need Russian visa should contact **in advance** the Embassy of Russia in respective country or the nearest Consulate in a neighbour country. Also we kindly ask you to send to Boxing Federation of Russia **copies of passports** of all members of your delegation and full list of your delegation. Please inform us in what city you will apply for Russian visa.
