Russian Boxing Federation is proud to invite your National Team to participate in the upcoming St. Petersburg Governor's Cup International Boxing Tournament to be held on May 17 - 24 2020 in Saint Petersburg, Russia.

RULES

The Tournament is held in accordance with AIBA Rules for the Elite Male division. Boxers compete in 8 weight classes, namely **52 kg, 57 kg, 63 kg, 69 kg, 75 kg, 81 kg, 91 kg, 91+ kg**.

ATHLETE ELIGIBILITY AND TEAMS

Members of the National Elite Male Boxing Teams, bearing AIBA Record Books and aged 19-40 (born between 1980 and 2001) are eligible for the Tournament.

PLEASE NOTE: AS STATED BY THE AIBA RULES, ACCIDENT INSURANCE IS MANDATORY FOR ALL PARTICIPATING ATHLETES. INSURANCE POLICY ORIGINALS SHOULD BE HANDED IN TO THE TECHNICAL MEETING.

Each National Team is eligible to enter a delegation of up to:

- 6 boxers
- 2 coaches
- 1 EUBC\AIBA R&J

Team Russia will be represented by 2 boxers in each weight class.

Bringing national flags and anthem records on CD or USB drives is advised and highly encouraged.

ENTRIES AND REGISTRATION

We kindly ask you to send in the numerical entries before April 07th, 2020. Final entries are accepted before April 13th, 2020.

While filing in the final entries, please inform us if there are athletes of special dietary needs or restrictions (e.g. Muslim, Jewish, Hindu, Buddhist or vegan\vegetarian).
