Ukrainian Boxing Federation in cooperation with Kherson Boxing Federation invites national boxing Federations to take part in the International boxing tournament (group A) dedicated to the memory of the honored coach of Ukraine Nikolai Manger.

The tournament will take place in Kherson, Ukraine during **April 01-07, 2021**.

The arrival date – **April 01, 2021** the departure date – **April 07, 2021**.

The tournament will be held in accordance with AIBA Technical and Competition Rules in 8 weight categories. Bouts will consist of 3 rounds 3 minutes each with 1 minute break between the bouts. Electronic judging system will be used. Boxers born between the age 19-40 (2002-1981) may take part in the tournament. The boxers must have valid international AIBA record books, red and blue uniforms. The judges must have a valid international AIBA passport. *Each team is obliged to bring 1 (one) AIBA 1,2- or 3-star judge.*

**Team Composition**

National Federations can send maximum 8 boxers – one in each weight category.  
Weight Categories: 52kg, 57kg, 63kg, 69kg, 75kg, 81kg, 91kg, +91kg.

**Financial Conditions**

The organizers will provide accommodation and full board for the team in composition:  
4 boxers + 1 coach +(1 judge mandatory) Boxers and officials excess of this number must pay for their accommodation and board:

## **Team hotel**

- Single room (including 3 meals) – 65 EURO/per night/per person
- Double room (including 3 meals) – 55 EURO /per night/per person

## **Entry / Visa request**

National delegations must obtain visa in the Ukrainian embassy in their country.

Request for visa support letter should be send to Ukrainian Boxing Federation not latter than **March 15, 2021** to [ukrboxing@gmail.com](mailto:ukrboxing@gmail.com) with names, date of birth and passport details.

## **Insurance**

All participants are requested to get their own travel and medical insurance. LOC will provide liability insurance only at the Competition Venue for all participants. The LOC will provide medical care and first-aid during the entire event to all participants who suffer from a sport injury (contracted during the event)

## **Payment**

Team Delegations requested to make payment in cash upon arrival.

## **Prizes**

The boxers winning the 1-3 places will get medals, diplomas and valuable prizes.

## **Covid-19 PROTOCOL FOR TEAM DELEGATIONS**

All official members of Team Delegations, whether they are competitors or staff, international or local are obligated to:

- Present, on arrival, an individual COVID-19 medical certificates (*PCR test made within 48 hours before arrival*) with a negative result.
- Appoint a COVID-19 contact person from the official Team Delegation list, who will be present during the Tournament and will be in charge of any COVID-19 related issues for their Team Delegation.
- Wear a mask at all times during the Tournament, with exceptions of:
  - o boxers in training when it is not possible to wear it
  - o participants during their meals only when seated at their dining table
- Observe social distancing at all times (1,5 m), except for boxers during their bouts and during warming up with their coach.
- Avoid entering hotel rooms of other participants under any circumstances.
- Avoid any contact with individuals who are not on the training camp as workers, other athletes.
- Submit to contactless temperature screening by the LOC and/or local health authorities at any time during the Tournament
- Submit to COVID-19 testing at any time during the Tournament on request of LOC COVID-19 Managers and/or local health authorities
- Follow all instructions of LOC COVID-19 Event Managers, including following isolation, quarantine, observation procedures and provision of detailed contact tracing in case of need
- Timely report all COVID-19 protocol violations during the Event to EUBC/LOC COVID-19 Managers
