**about holding the XII international boxing competition
among juniors 17-18 years in memory of MSMC Nikolay Pavlyukov
Number - code of the sport 0250008611YA**

**September 14-19, 2021,
Krasnodar**

1. General provisions

The international tournament is held in accordance with the plan of international competitions of the EUBC (European Boxing Confederation) for 2021, is held in accordance with the Unified calendar Plan of interregional, All-Russian and international physical culture events, and sports events of the Ministry of Sports of Russia for 2021.

Competitions are personal in nature, held in accordance with the rules of the competition "AIVA".

It is prohibited to exert illegal influence on the results of sports competitions included in this regulation on interregional and all-Russian official sports competitions.

It is prohibited to participate in gambling in bookmakers and sweepstakes by betting on official sports competitions in accordance with the requirements established by paragraph 3 of Part 4 of Article 26.2. of Federal Law No. 329-FZ of December 4, 2007 "On Physical Culture and Sports in the Russian Federation".

This Regulation regulates issues related to the organization and conduct of these competitions and is the basis for sending athletes, coaches, representatives, judges, officials and other specialists as part of delegations.

2. Goals and objectives of the competition

The tournament is held to promote boxing in Russia and sets the following objectives::

- strengthening of friendly and sports ties with the regions of Russia and with the countries of the near and far abroad;
- improving sports skills and gaining experience in conducting international fights by athletes of the junior national team of Russia;
- identification of the strongest athletes and preparation of athletes of the junior national team of Russia for the largest international competitions

This Regulation regulates issues related to the organization and conduct of these competitions and is the basis for sending athletes, coaches, representatives, judges, officials and other specialists as part of delegations.

3. Competition Rights

The rights to hold the competition belong to the Russian Boxing Federation.

The organization and holding of the tournament is entrusted to the Boxing Federation of the resort city of Anapa, together with the state budget institution of the Krasnodar Territory "Regional Center for Sports Training in Boxing" and the judging panel.

4. Ensuring the safety of participants and spectators

Competitions are held at sports facilities that meet the requirements of the relevant regulatory legal acts in force on the territory of the Russian Federation and are aimed at ensuring public order and the safety of participants and spectators, as well as in the presence of acts of readiness of a sports or sports facility for holding events approved in accordance with the established procedure.

Ensuring the safety of participants and spectators during competitions is carried out in accordance with the requirements of the Rules for Ensuring Safety during Official Sports Competitions, approved by the Decree of the Government of the Russian Federation No. 353 of April 18, 2014.

The provision of emergency medical care is carried out in accordance with the order of the Ministry of Health of the Russian Federation of March 01, 2016. No. 134 n " On the procedure for organizing the provision of medical care to persons Engaged in physical culture and sports (including during the preparation and conduct of physical culture events and Sports Events), including the procedure for medical examination of persons wishing to undergo sports training, engage in physical culture and sports in organizations and (or) meet the standards of tests (tests) All-Russian sports complex "Ready for work and defense".

Anti-doping support in the Russian Federation is carried out in accordance with the All-Russian Anti-Doping Rules approved by Order No. 947 of the Ministry of Sports of the Russian Federation of August 9, 2016.

Responsible performers: the head of the state budgetary institution of the Krasnodar Territory "Regional Center for Sports Training in Boxing", the head of the sports facility, the chief judge of the competition.

5. Insurance of participants

Participation in the competition is carried out only if there is a contract (original) on accident insurance (life and health), which are provided to the organizing committee of the competition. Insurance may be provided by the sending organizations and / or by the athletes themselves.

6. Venue and dates of the competition

Competitions are held from **September 14 to 19, 2021** in the city of Krasnodar at the address: 350087, Russia, Krasnodar Territory, Krasnodar, Prigorodnaya str., 24, MSC Basket Hall, main Arena.

Participants ' accommodation: MARTON LEADER Hotel, 101 Dzerzhinskiy str., Krasnodar Territory, 350051, Russia.

Arrival day-**September 14, 2021**, departure day-**September 19, 2021**.

The competition program is listed in Appendix No. 1 to this Regulation.

7. Competition organizers

The organizer of the competition is the Boxing Federation of Russia, the Boxing Federation of the resort city of Anapa, the state budgetary institution of the Krasnodar Territory " Regional Center for Sports Training in Boxing "(hereinafter – GBU KK"RCSP in boxing"). The direct conduct of the competition is assigned to the main judging panel, approved by the Russian Boxing Federation in coordination with the international Federation.

8. Participants of the competition

Boxers born in 2003-2004 are allowed to participate in the competition as part of the teams of Russia, CIS countries, and far abroad.

Weight categories: up to **46, 48, 51, 54, 57, 60, 63,5, 67, 71, 75, 80, 86, 92 kg.**

The delegation from each country consists of 11 people: 7 athletes, 2 coaches, 1 head, 1 judge of the ECB or AIBA.

The Russian national team is represented by two teams: 22 athletes, 5 coaches, 1 doctor, 1 massage therapist.

9. Summing up conditions

Competitions are held according to the system with elimination after the first defeat. In each weight category, the first, second and two third places are played.

10. Award ceremony

The winners are awarded with diplomas, medals, valuable prizes and belts of the winner. Athletes who take 2nd and 3rd places in each weight category are awarded with diplomas, medals and valuable prizes.

11. Terms of financing.

Expenses for travel from the place of residence to Krasnodar and back of athletes, coaches, judges, officials at the expense of sending organizations.

The costs associated with testing for a new coronavirus infection (COVID-19) by polymerase chain reaction (PCR) are provided by the sending organizations.

The Anapa Boxing Federation bears the costs of accommodation with full board for the participants of the national teams of the participating countries. If the size of the team exceeds the number specified in this regulation, as well as in the case of arrival of teams earlier than the specified date (September 14, 2021) and departure later than the specified date (September 19, 2021), the participants pay the cost of accommodation at the rate of 50 Euros per person per day.

Additional financial support related to organizational expenses for the preparation and conduct of sports competitions is provided at the expense of the grant of the State Budget Institution of the RCSP for Boxing to ensure the implementation of the state task for the provision of public services (performance of works) in 2021 and bears the following expenses: payment for service personnel; payment for services for the provision of emergency medical care, with an ambulance; payment for security services, payment for services for the organization and conduct and participation in the organization and conduct of solemn ceremonies.

The state budgetary institution of the Krasnodar Territory "Multifunctional Sports Complex", provides the venue for the competitions of the GBU KK "RCSP in boxing" on a free basis.

The costs of organizing and conducting competitions, paying for the work of judges (based on the decision of the Executive Committee of the Russian Boxing Federation No. 6 of 09.12.2018), service personnel, awarding winners and prize-winners, transport services for participants, are borne by the Boxing Federation of the resort city of Anapa. Entry fees are not charged.

12. Applications for participation

Registered applications with the date of arrival (flight number, train number), copies of passports of all team members, are submitted to the Russian Boxing Federation by **August 14, 2021** by phone /fax **(495) 637-07-42, 637-06-58** or by e-mail: reception@rusboxing.ru and in the GBU CC "RCSP on boxing" by e-mail: sboxing_rcsp@mail.ru .

Participants of the competition must submit the following documents to the admission commission:

- an application certified by a doctor;
- AIBA boxer's passport;
- MRI of the brain (copy of the original);
- passport of a citizen of the Russian Federation, for athletes of non – foreign teams-international passport;
- compulsory health insurance policy;
- athletes, coaches, team representatives, and the judging panel must have a certificate with a negative test result for a new coronavirus infection (COVID-19) by polymerase chain reaction (PCR), issued no earlier than 3 calendar days before the start of the sports event.

This regulation is an official challenge to the competition.
