



# **EUROPEAN WOMEN'S TEAM CUP**

**“Season 1” - 2016**

**KEY COMPETITION RULES**

## **RULE 1. COMPETITION FORMAT AND POINTS ATTRIBUTION**

- 1.1. European Women's Team Boxing Cup will be held in two Phases (Preliminaries and Finals) starting from February 2016.
- 1.2. The minimum number of participating Teams for the first Edition is eight (8)
- 1.3. In case of more than 8 Teams the groups will be created so not to exceed 4 teams in each group and not go under the 3 teams in each group.
  - 9 Teams: 3 groups of 3 teams. The first 1° and 2° classified in each group and the best two 3° classified teams will be qualified for the Finals.
  - 10 Teams: 1 group of 4 teams and 2 groups of 3 teams. The first three 1° and 2° classified of each group and the two best 3° classified teams will be qualified for the Finals.
  - 11 Teams: 2 groups of 4 teams and 1 group of 3 teams. The first three 1° and 2° classified of each group and the two best 3° classified teams will be qualified for the Finals
  - 12 Teams: 3 groups of 4 Teams. The first three 1° and 2° classified of each group and the two best 3° classified teams will be qualified for the Finals
  - 13 Teams: 1 group of 4 Teams and 3 groups of 3 teams. The 1° and 2° classified teams of each group will be qualified for the Finals.
  - The same criteria will be used in case of more participating Teams.
- 1.4. Each Phase will have the duration of five (5) days including arrivals and departures.
- 1.5. During the Preliminary Phase the registered Teams will be drawn into two (2) or more Groups of four (4) or three (3) Teams each where the Teams will compete against each other in order to obtain the maximum number of points.
- 1.6. After the Preliminary Phase the first eight (8) classified Teams will be qualified for the Finals.
- 1.7. In case of more than 8 participating Teams the qualification to the Finals will be obtained by the 1° classified Team of each Group plus the best 2° and 3° classified Teams until the number of 8 Teams will be reached.
- 1.8. During the Preliminary Phase the following points will be attributed:
  - Score 5-0, 4-1, 4-0, 3-0, 2-0, 1-0: the winning Team will get three (3) points and the losing Team will get zero (0) points;
  - Score 3-2, 3-1 or 2-1: the winning Team will get three (3) points and the losing Team will get one (1) point;
  - Draw: each Team will get two (2) points
- 1.9. The ranking of the Teams will be decided by the highest number of points won during the Preliminary Phase. In case of equal points, it will be decided by (in descending order):
  - Winner of the match between the teams in question
  - Difference between the won and lost bouts
  - Least number of W.O
  - Total sum of individual judges scores of the preliminary bouts (difference between the positive and negative sum)
- 1.10. The best 2<sup>nd</sup> and 3<sup>rd</sup> Teams will be decided by the highest number of points won during the Preliminary Phase. In case of equal points, it will be decided by (in descending order):
  - Difference between the won and lost bouts
  - Least number of W.O
  - Total sum of individual judges scores of the preliminary bouts (difference between the positive and negative sum)

- 1.11. Decision of the winner in the Finals in case of Draw
- Least number of W.O
  - Total sum of individual judges scores of the preliminary bouts (difference between the positive and negative sum)

## **RULE 2. COMPETITION SCHEDULE**

### 2.1. Competition Schedule

Preliminaries: 5 days (groups A and B or more)

## **RULE 3. AGE CLASSIFICATION**

3.1. Only Elite Boxers are eligible to compete in the European Women's Team Boxing Cup.

## **RULE 4. ELIGIBILITY OF BOXERS**

- 4.1. It is mandatory that each Team has a minimum of two (2) Boxers per Weight Category. There is no upper limit on the number of Boxers that a Team may have.
- 4.2. The Teams may be composed of National end foreign Boxers.
- 4.3. The maximum number of International Boxers per Team is 8 (eight) Boxers.
- 4.4. There is no maximum number of International Boxers from the same country permitted.

## **RULE 5. WEIGHT CATEGORIES**

5.1. The Competition will be held in the following weight categories: 51 kg, 54 kg, 60 kg, 64 kg, 75 kg,

## **RULE 6. NUMBER OF ROUNDS**

6.1. Each Bout will consist of four (4) rounds of two (2) minutes, one (1) minute rest between rounds.

## **RULE 7. TEAMS COMPOSITION**

7.1. Each Team should be composed of 5 starting Boxers and a minimum of two (2) reserve Boxer in each weight category.

## **RULE 8.COMPETITION OFFICIALS**

9.1. For each Phase of EWC, EUBC will appoint the following Officials:

- 1 Supervisor
- 2 Deputy Supervisors
- 7 international Technical

## **RULE 10. REFEREES & JUDGES**

10.1. Each Team should mandatory include an AIBA 2 – 3 Star Referee & Judge to officiate in the Competition.

10.2. The name of the selected R&J by each participating National Federation Team must be submitted to EUBC during the Boxer's registration period.
